**SENATE COMMITTEE ON REAPPORTIONMENT AND  
REDISTRICTING RULES  
2007-2008 TERM**

- 1) The quorum for the Committee shall be eight (8) members.
- 2) The Committee shall convene, recess, and adjourn upon the order of the Chairperson.
- 3) The Chairperson shall determine measures to be considered and the order in which such measures are considered.
- 4) The Rules of the Senate shall prevail in all matters not covered by these Committee Rules.
- 5) These Committee Rules may be amended upon motion duly made and seconded and subsequently approved by two-thirds (2/3) of the members of the Committee provided that written notice has been given twenty-four (24) hours prior to the Committee meeting.

A meeting of the **Reapportionment and Redistricting Senate Committee** was held on Wednesday, February 7, 2007.
