### 2014

- 1. Quorum of the committee shall be four (4) members.
- 2. The Chairperson shall determine which bills and resolutions are to be considered and the order in which said measures are considered.
- 3. The Chairperson shall have the authority to refer bills and resolutions to subcommittees for study. Subcommittees in turn shall have authority to make recommendations on such measures to the full committee at such time as shall be designated by the chairperson. All actions of any subcommittee shall be approved or disapproved by the standing Committee.
- 4. The committee shall convene, recess, and adjourn upon the order of the chairperson.
- 5. A bill or resolution will be considered only after presentation by its principal author or other legislator whom he or she may designate. The principal author shall be the legislator whose name appears first on the list of authors.
- 6. Any member or members of the committee who disagrees with the majority report of the committee shall be privileged to file a minority report if they so desire.
- 7. These rules may be amended upon a motion duly made and subsequently approved by two-thirds of the members of the committee.
- 8. Bills and resolutions, at the option of the Chairman, may be acted on at the first reading.
- 9. All meetings of the Committee shall be open to the public in accordance with Senate Rule [1-5.1].
- 10. The Secretary of the Committee will have a copy of these rules distributed to all members of the Senate.
- 11. Where these rules are silent on a specific issue, the Rules of the Senate as adopted shall govern.

## Minutes of the Senate Veterans, Military and Homeland Security Committee February 25, 2014

The Veterans, Military & Homeland Security Committee was called to order at 11:33 a.m. in Room 450 of the Capitol, with Chairman Ed Harbison of the 15<sup>th</sup> presiding.

Senator Harbison opened the meeting by welcoming committee members and guests, and introducing all committee members. He announced that Senate Bills 381 and 276 were on the agenda.

## SB 381 (Senator Beach, 21<sup>st</sup>) - "Georgia First Informer Broadcasters Act"; provide planning for first informer broadcasters; definitions

A BILL to be entitled an Act to amend Code Section 38-3-57 of the Official Code of Georgia Annotated, relating to the establishment of a standardized, verifiable, performance based unified incident command system for emergencies, so as to provide planning for first informer broadcasters in the unified incident command system and the Georgia Emergency Operations Plan; to provide a short title; to provide for definitions; to provide for related matters; to repeal conflicting laws; and for other purposes.

Senator Beach introduced his bill stating that this bill directs the unified incident command system and the Georgia Emergency Operations Plan to establish specific planning for first informer broadcasters.

Speakers in support of the bill: Randy Gravley and Joseph Brannan with Georgia Association of Broadcasting

Mr. Gravley and Mr. Brannan spoke on the bill and on behalf of the Georgia Association of Broadcasting. They have met with Senator Beach and support the legislation.

After further discussion, a motion was made by Senator Hunter Hill that <u>SB 381</u> Do Pass. Senator Gail Davenport seconded the motion. The motion passed 4-1. Senator Mike Dugan voted no on the bill.

Senator Harbison took a moment to introduce and thank Commissioner Pete Wheeler who was present at the meeting.

# <u>SB 276</u> (Senator Harbison, 15<sup>th</sup>) State Government; provide that Georgia shall be a "Purple Heart State"

A BILL to be entitled an Act to amend Article 3 of Chapter 3 of Title 50 of the Official Code of Georgia Annotated, relating to other state symbols, so as to provide that Georgia shall be a "Purple Heart State"; to repeal conflicting laws; and for other purposes.

Senate Bill 276 was introduced and explained by Senator Harbison. This bill is a simple bill that designates Georgia as a "Purple Heart State," honoring our combat wounded veterans for their service and sacrifice in allowing the United States of America to maintain its sovereignty.

After further discussion, a motion was made by Senator Hunter Hill that <u>SB 276</u> **Do Pass**. Senator Bruce Thompson seconded the motion. The motion passed unanimously.

Each member supported the resolution and thanked Senator Harbison for bringing it before the committee.

There being no further business, the meeting was adjourned at 11:48 a.m.

Mr. Wise thanked Senator Harbison for his leadership and guidance through the years. He stated that the Veterans Education Programs will allow us to better ourselves through education and hopefully become a nationwide program.
