RULES
Senate Committee on State and Local Governmental Operations
2015 Legislative Session

1. Quorum of the Committee shall be four (4) members.
2. The Chairman shall determine which cases or investigations shall be heard and the order in which said hearings are to commence.
3. The Committee will not hear a bill unless the Chairman receives a written request for a hearing from the author of the bill.
4. The Chairman shall have the authority to refer cases or investigations to Subcommittee for study. Such Subcommittees, in turn, shall have the authority to make recommendations on such cases to the full Committee.
5. The Committee shall convene, recess, put forward questions and adjourn upon order of the Chairman, subject to the Rules of the Senate.
6. Any member or members of the Committee who disagree with the majority report of the Committee shall be privileged to file a minority report.
7. If a Committee member moves on a House bill without a Senate sponsor, that Committee member becomes the sponsor of the bill.
8. After adoption, these rules may be amended upon motion duly made, seconded, and subsequently approved by a two-thirds vote of the members of the Committee.
9. The Secretary of the Committee shall distribute a copy of these rules to all members of the Senate State and Local Governmental Operations Committee.
10. Where these rules are silent on a specific issue, the Rules of the Senate, as adopted, shall govern.

SB 11 (Sen. Lucas, 26th, LC 21 3548) Payne City; abolish; provide for disposition of the assets, property, and legal rights

Sen. Lucas, Sr. (26th) said that the bill was a local bill being passed as a general bill. He proceeded to explain the bill, which repeals the Charter for Payne City. Sen. Albers (56th) commented that Sen. Jones from Bibb County also agrees with the bill. Sen. Lucas, Sr. (26th) confirmed that all Senators from the area were in agreement. Sen. Albers (56th) asked if anyone wished to speak for or against the bill, and seeing none, he asked for any motions.

This was the third meeting of the Senate State and Local Governmental Operations Committee of the 2015 Legislative Session. Sen. Albers (56th) welcomed Committee members, staff, and guests, then asked Sen. Martin (9th) to open the meeting with a prayer.

[HB 73](#) (Rep. Turner, 21st, LC 28 7301) Public officers; counties and municipalities provide by local law for district durational residency requirements; authorize

Rep. Scot Turner (21st), the author of HB 73, spoke on its behalf.

Sen. Butler (55th) made a motion **Do Pass** and Sen. Martin (9th) seconded the motion. The motion passed by a vote of 3-0.

HB 73 DO PASS

[HB 95](#) (Rep. Tanner, 9th, LC 34 4394ER) Local government investment pool; trust fund managed by state treasurer; provide

Rep. Kevin Tanner (9th), the author of HB 95, spoke on its behalf. Rep. Tanner (9th) said the bill provides the state treasurer with the option of placing state funds in a separate trust fund to be administered by the state treasurer pursuant to policies established by the state depository board.

Sen. Williams (27th) made a motion **Do Pass** and was seconded by Sen. Harbin (16th). The motion passed unanimously 4-0.

HB 95 DO PASS

[SB 189](#) (Sen. James, 35th, LC 28 7554) South Fulton, City of; incorporate; provide for a charter

Sen. Albers announced that he would be speaking on behalf of SB 189, as he is a cosponsor, and Sen. Donzella James (35th) was unable to attend the meeting. Sen. Albers (56th) clarified that the bill does not create the city of South Fulton, but it does allow South Fulton to vote on the issue. Sen. Martin (9th) asked if it is correct that the new city would not have to have a police force, but could actually contract out. Sen. Albers (56th) confirmed this, and asked if there were any further questions. Sen. Williams (27th) asked what the millage rate was capped at. Rep. LaDawn Jones (62nd) said the millage rate was capped at .1 mill above its current amount. She said additional revenue will help set up the facilities of the new city. Sen. Williams (27th) asked if there had been a Carl Vinson Institute (University of Georgia) Feasibility Study. Rep. Jones (62nd) confirmed this. Sen. Albers (56th) said he would then call names from the sign-up sheet listing those requesting to speak. Aaron Johnson testified that representation of the area is complicated, and becoming a city would allow for simpler representation. Secondly, he cited a financial concern. Alvin Reynolds said the residents of South Fulton would like the opportunity to vote on their future well-being. Rasheen Hunter, Damita Chatman, Gladstone Nicholson, and Helen Willis then testified in support of the bill. Sen. Williams (27th) asked where the funds came from for the institute study. Mrs. Willis replied that it was paid for by funds raised through South Fulton United. Bryant Tate and Rafer Johnson then testified on behalf of the bill. Sen. Williams (27th) asked how many people were on the Board of Commissioners. Mr. Johnson replied that there were seven. Sen. Williams (27th) asked how many represent South Fulton. Mr. Johnson replied that one representative lives in South Fulton, but a different representative represents South Fulton. He clarified that there is no exclusive representative for unincorporated Fulton, but it was more or less two representatives out of the total seven. Sen. Harbin (16th) asked how close the boundaries of the city would come to Camp Creek. Mr. Johnson explained that it would come right up to, but not over the boundary of Camp Creek. Next, Deborah Bazemore testified in support of the bill. She said she was the Chair for South Fulton United. She said that in order to run for office, a candidate must live in South Fulton for at least one year, which ensures candidates have a vested interest in the area. Sen. Williams (27th) asked if the county was the only avenue of representation for South Fulton, and whether it was correct that only two out of seven represent South Fulton on the Board of Commissioners. Ms. Bazemore confirmed both these concerns. Sen. Albers (56th) asked if there were any more questions, and hearing none, asked for any motions.

SB 189 HEARING ONLY

SB 186 (Sen. Heath, 31st, LC 34 4495) Counties, Municipalities, Other Entities; provide for electronic publication for certain public notices; procedures, conditions, and limitations

Sen. Albers (56th) asked Sen. Heath (31st) and Todd Edwards of the Association of County Commissioners of Georgia (ACCG) to speak on behalf of SB 186. Sen. Heath (31st) provided the Committee with documents on counties that support the bill, and with projected savings through the bill. Sen. Heath (31st) said that the bill provides the option to local governments of publishing required notices online. He said the bill sets forth a method for publishing these notices, and guidelines to ensure easy access by the general public. He said that the data shows an average potential savings of \$900 a year per

county. Sen. Heath (31st) added that not all legal organs have online access, and this bill would save money, but it is not a mandate. He continued that the bill is just an option that counties could either opt in or out of. He asked Todd Edwards if he had anything to add. Mr. Edwards said that there are many safeguards within the bill to maintain transparency and accountability. He said that there are provisions to mail or email notices to anyone who signs up for this option. Local governments would have to advertise once a month for 12 months if they wish to pursue this avenue, and they would have to write into their official code. He added that Constitutional Law Officers have the option to do whatever they want. He argued that this bill increases transparency and decreases unnecessary costs. Sen. Albers (56th) asked if there were any questions. Sen. Kirk (13th) asked if everyone would be able to access the notices, and added that it could make search engine searches confusing, with many local governments advertising their official notices. Mr. Edwards said that links to official websites could be found through the local government's official website. Sen. Kirk (13th) asked if this would not be an extra burden on the elderly. Sen. Heath (31st) replied that the county could take requests for mailed notices over the phone. Sen. Kirk (13th) said that he could not support SB 186 unless it said 'current legal organ and online'. Sen. Heath (31st) said the language is permissive and does not prohibit printing the notices in the current legal organ. Sen. Martin (9th) expressed his concern that information would be more difficult to find, and asked if there could be a single place to access notices. Sen. Heath (31st) said that all notices for a county could be found on the county website. Sen. Martin (9th) asked if the regular deadlines would still be followed. He also expressed his concern that eliminating the legal organ would eliminate third-party accountability. Sen. Butler (55th) voiced similar concerns to her fellow Committee members.

NOTE: Sen. Martin (9th) left the meeting.

Mr. Edwards commented that electronic documents would still have to be filed with the clerk. Sen. Kirk (13th) replied that that would not constitute third-party review. Robert Williams of Southfire Newspapers in Blackshear, GA testified against the bill. Mr. Williams said local areas depend on newspapers to communicate government notices in a clear and timely manner. He expressed concerns that public notices could appear in multiple locations instead of one easily accessed location, that local government websites can be hacked, and that online maintenance would be costly. Sen. Albers (56th) asked if Sen. Heath (31st) would like to make a closing argument. Sen. Heath (31st) said the bill could be amended to require third-party review. He added that notices could easily be consolidated in one link on the local government's webpage, and would be much easier accessed than a printed notice through a paper that must be purchased. He continued that counties have to pay newspapers to print notices, which their residents then have to buy, which constitutes an unnecessary cost not only to counties, but to residents as well. Finally, he asked Mr. Williams how he accessed the content of SB 186. (Contents of Senate bills can be found on the General Assembly webpage). Sen. Albers (56th) asked if there were any additional questions, and hearing none, he asked for motions.

Sen. Williams (27th) made a motion **Do Pass** and Sen. Harbin (16th) seconded the motion. The vote was 2-2. Sen. Albers (56th) broke the tie by voting in favor of the motion. The

motion passed with a vote of 3-2. Sen. Williams (27th), Sen. Harbin (16th), Sen. Albers (56th) all voting yay, with Sen. Butler (55th) and Sen. Kirk (13th) voting nay.
