- 7. A bill, resolution, or other matter will be considered only after a presentation by its principal author or a legislator whom he or the Chairman designates to do so. In the event more than one member of the General Assembly has signed a measure, the principal author shall be the one whose name appears first in the list of authors.
- 8. Substitutes and amendments shall be provided to the Chairman at least twenty-four (24) hours prior to the hearing. The Chairman reserves the right to delay action on any substitute or amendment not provided in advance.
- 9. Where these Rules are silent on a specific issue, the Rules of the Senate, as adopted, shall govern.

SUBJECT: Fiscal Note House Bill 636 (CSFA)

#### Dear Chairman Ginn:

The bill would provide for the licensure of genetic counselors, authorizing the Georgia Composite Medical Board to issue, suspend, deny, and renew licenses. It defines genetic counselors, determines requirements for licensure, and provides details on renewing the license. The bill would not apply to companies providing services directly to consumers without seeing a physician or genetic counselor or to companies using genetic data for nutritional counseling.

Regulating the licensure of genetic counselors would require state funding of \$53,800 to \$64,200 per year. The estimated cost includes an initial IT cost of \$13,000 to add this profession to the Board's existing system, as well as \$64,800 in salary and benefits for an additional staff member to manage the profession. The Board would generate revenue to offset part of the cost through initial application fees (assumed at \$300) and renewal fees (assumed at \$150). According to the U.S. Bureau of Labor Statistics, there are an estimated 80 genetic counselors in Georgia, and this number is expected to grow 2.6 percent annually.
