# COMMITTEE ON HIGHER EDUCATION RULES – 2017 & 2018

- 1. These Committee Rules of Operations shall be consistent with Senate Rule 2-1.5 (d) regarding the establishment of Rules of Operation.
- 2. Quorum of the Committee shall be five (5) members.
- 3. The Chairman shall have the authority to refer bills and resolutions to be considered and the order in which said measures are considered; the Chairman shall have the authority to call a bill, resolution, substitute or amendment for debate and explanation only.
- 4. The Chairman shall have the authority to refer bills and resolutions to subcommittees for study. Such subcommittees in turn shall have the authority to make recommendations on such measures to the full Committee at such time as shall be designated by the Chairman.
- 5. The Committee shall convene, recess, and adjourn upon the order of the Chairman.
- 6. A bill or resolution will be considered only after presentation by its principal author or other legislator whom he/she may designate. The principal author shall be the legislator whose name first appears on the list of authors.
- 7. The Chairman reserves the right to delay action on substitutes and amendments not provided to the Chairman at least 24 hours prior to the hearing.
- 8. Any member or members of the Committee who disagree (s) with the majority report of the Committee shall be privileged to file a minority report if they so desire.
- 9. These rules may be amended upon a motion duly made and subsequently approved by two-thirds of the members of the Committee.
- 10. Where these rules are silent on a specific issue, the Rules of the Senate as adopted shall govern. (Senate Rule 2)

The following guest speakers from the Board of Regents, the Technical College System of Georgia, and the Georgia Independent College Association spoke on their current and immediate future policies on sexual assaults, due process and mandatory reporting.

# Ms. Kimberly Ballard-Washington, Associate Vice Chancellor of Legal Affairs, University System of Georgia

Ms. Washington spoke on current policy requiring incoming freshmen to complete online modules on sexual assault and alcohol abuse. She stated that problems include a percentage of students who have not completed the modules in their first semester. She stated that the University System of Georgia keeps reports of sexual assault and crime statistics.

# Ms. Linda Osborne-Smith, Deputy Commissioner, Technical College System of Georgia

Ms. Osborne-Smith explained current Technical College System of Georgia policies on sexual assault. In 2017, the Technical College System of Georgia received a total of 6 sexual assault complaints. Sexual assault awareness and prevention training are included in new student orientations and employee training. Ms. Osborne-Smith explained that Technical College System of Georgia policies require administrative investigations upon sexual assault allegations. Criminal investigations are separate from administrative investigations and are conducted by law enforcement. If the complaint involves a student under 18 years old, Technical College System of Georgia reports it to the Division of Family and Children Services as required by law. Colleges begin the disciplinary process

if an investigation substantiates the complaint. If the sanction is suspension or expulsion, the student has the right to a hearing before any action is taken and may appeal the recommended sanction to the president, who makes the final decision.

### Dr. Susanna Baxter, President, Georgia Independent College Association

Dr. Baxter explained sexual assault policies for private colleges. She explained that federal Title IX law is the basis for student codes of conduct and faculty/staff policies. There is a distinction between "due process" at public institutions and "fair process" at private institutions. Only students attending a public institution can sue that institution for a due process violation. The code of conduct policy at a private college serves as a contract between the student and the institution. Georgia Independent College Association members include a "Fair Process" (notice of hearing; hearing and right to appeal) in these policies. If a student believes that the private college did not follow its policy, the student can sue the private college based on a "breach of contract." Dr. Baxter stated that it is considered best practice to not have mandatory reporting. Dr. Baxter explained that the Georgia Independent College Association has created a statewide coalition with over 100 participants from over 33 institutions to address campus health issues, including sexual violence. She added that private colleges have partnered with the University System of Georgia to ensure that all students, including dual enrolled students, complete online training courses.
