SB 281 – LC33 6511ERS - Ligon, 3rd: relates to instructional materials and content in elementary and secondary education, so as to require schools to provide certain information to students and parents prior to using any digital...

SB 310 – LC33 6509S - Ligon, 3rd: Requires all grants affecting pre-K thru grade 12...submit detained information regarding several aspects of the grant.

SB 355 – LC 33 6553ERSS - Ligon, 3rd: "Student Protection Act"; to end punitive testing consequences for students...

Hearing Only:

SB 124 – LC – 33 5958ER - Fort, 39th: Creates a 5-year Sustainable Community School Operational grant to be issued and administered by D.O.E allowing for school sites to implement community schools. Establishes requirements...

SB 92 – LC 33 5875 – Hill 6th: Creates an Educational Savings Account (ESA) infrastructure; Establishes law governing the administration of the ESA.
