The Joint House and Senate Retirement committees will be meeting on Wednesday, April 17, 2013 in room 406 CLOB at 10:00am. This joint committee meeting is necessary for the fiscal bills that are reviewed after Session is over in the first part of the two year Session.

SB 52 – LC 21 1873 – Carter, 1st - Act to amend Chapter 17 of Title 47 of the Official Code of Georgia Annotated, relating to the Peace Officers' Annuity and Benefit Fund, so as to amend a certain definition; to provide that certified peace officers employed by a public entity to perform duties in conjunction with the operation of a public airport shall be eligible for membership in such fund; to provide for credit for prior service; to authorize any such public entity to make contributions to such fund; to provide conditions for an effective date and automatic repeal; to repeal conflicting laws; and for other purposes.....This is a Fiscal bill

SB 235 – LC 21 2160 – Albers, 56th – Act to amend Chapter 7 of Title 47 of the Official Code of Georgia Annotated, relating to the Georgia Firefighters' Pension Fund, so as to change the definition of the term "firefighter"; to provide for creditable service for certain prior service; to provide conditions for an effective date and automatic repeal; to repeal conflicting laws; and for other purposes....This is a Fiscal bill
