**SB 332 LC 29 5822 – Stone, 23<sup>rd</sup>** - Act to amend Code Section 15-10-2 of the Official Code of Georgia Annotated, relating to the jurisdiction of magistrate courts, so as to increase the fine amount for contempt of court....

**HB 296 LC 29 5833S - Powell, 32<sup>nd</sup>** - an Act to amend Title 40 of the Official Code of Georgia Annotated, relating to motor vehicles and traffic, so as to add certain persons to those authorized to receive motor vehicle registration records; to add certain persons to the list of persons authorized to receive motor vehicle certificate of title records; to provide for the Department of Revenue to establish certain procedures and to promulgate rules and regulations....
