SR 1053 LC 41 0212 – McKoon, 12th - Resolution creating the Senate Study Committee on the Court of Appeals Workload.....

HB 654 LC 29 5871S – Oliver, 82nd - Act to amend Code Section 29-2-4 of the Official Code of Georgia Annotated, relating to nomination of testamentary guardian, so as to change provisions relating to the appointment of a testamentary guardian; to provide for objections to the nomination of a testamentary guardian and procedure

HB 790 LC 29 5883S – Williams, 119th - Act to amend Article 2 of Chapter 3 of Title 9 of the O.C.G.A., relating to specific periods of limitation, so as to provide for a four-year statute of limitations for actions involving the removal of timber from the property of another; to amend Part 1 of Article 1 of Chapter 6 of Title 12 of the O.C.G.A., relating to the State Forestry Commission; to amend Code Section 12-6-23 of the O.C.G.A., relating to wood load ticket required for wood removal; to amend Chapter 4 of Title 44 of the O.C.G.A., relating to real estate boundary determinations, so as to repeal provisions relating to processioning
