SB 159 LC 29 5459, Ligon 3rd –Relating to the Uniform Statutory Rule Against Perpetuities so as to change provisions relating to the validity of non-vested property interest or power of appointment....

SB 185 LC 29 5491ER – Stone, 23rd - Relating to secured transactions, as to modernize the article; to change and provide for definitions; to amend Code Section 33-10-1 of the Official Code of Georgia Annotated, relating to assets considered in determining financial condition of insurers

SB 187 LC 28 6599 – Hill, 32nd - Relating to requirements, procedures, and conditions for verification of lawful presence within the United States, so as to provide exemptions for the board of commissioners of the Georgia Student Finance Commission and the board of directors of the Georgia Student Finance Authority.....

SB 193 LC 41 0061 – Cowsert, 46th - A bill to be entitled an Act to amend Chapter 11 of Title 19 of the Official Code of Georgia Annotated, relating to the enforcement of duty of support, so as to update the Uniform Interstate Family Support Act; to repeal conflicting laws; and for other purposes....
