• **BILL HEARINGS:**

- **HB 508 (LC 43 0108) – Rep. Fleming, 121st** - A BILL to be entitled an Act to amend Code Section 47-2-244 of the Official Code of Georgia Annotated, relating to optional benefits available to appellate court judges, notice of election of benefits, eligibility for benefits, disability benefits and survivors benefits, so as to decrease the age of eligibility for certain benefits; to provide conditions for an effective date and automatic repeal; to repeal conflicting laws; and for other purposes.
- **HB 605 (LC 43 0175S) – Rep. Weldon, 3rd** - A BILL to be entitled an Act to amend Code Section 47-23-63 of the Official Code of Georgia Annotated, relating to definition and effect of full-time and part-time service and calculations, so as to provide that a member of the Georgia Judicial Retirement System who was serving in a full-time position on his or her retirement may use prior part-time service for vesting; to provide conditions for an effective date and automatic repeal; to repeal conflicting laws; and for other purposes.

- **HB 635 (LC 43 0171S) – Rep. Epps, 144th** - A BILL to be entitled an Act to amend Chapter 11 of Title 47 of the Official Code of Georgia Annotated, relating to the Judges of the Probate Courts Retirement Fund, so as to increase the number of years of mandatory contribution to such fund; to increase the maximum number of years used to calculate benefits; to provide for certain creditable service; to provide for application and payment of funds; to provide conditions for an effective date and automatic repeal; to repeal conflicting laws; and for other purposes.
