- **SB 262 (Sen. Strickland, 17<sup>th</sup>) Deannexes territory from Stockbridge and transfers it to Eagle's Landing through annexation; Annexes territory into Stockbridge from unincorporated Henry County. (LC 28 8638S)**
- **SB 263 (Sen. Strickland, 17<sup>th</sup>) Proposes the incorporation of the City of Eagle's Landing in Henry County, contingent upon voter approval by the qualified voters of the proposed city during the 2018 general primary. Establishes the city government structure, its powers and duties, as well as its corporate limits (Appendix A).<sup>1</sup> (LC 28 8639S)**
