Dear Lieutenant Governor Cagle,

Senate Resolution 1200, passed during the 2014 Legislative Session. It created the Study Committee on School Discipline to examine the disparities across the state as to how local school systems discipline their students, review the type of punishments imposed by various school systems, evaluate the time spent in alternative schools by students in various school systems, assess the high rate of expulsion of students and identify any operational disparities between students of different racial backgrounds. The Committee was authorized to conduct up to five public meetings, and currently stands abolished on December 1, 2014.

Because of the importance of this issue, and the time needed to complete a detailed final report, I respectfully request your approval to extend the Committee's date of abolishment to December 31, 2014, so that the Committee members may have enough time to agree on final recommendations.

Pursuant to Senate Resolution 4, which as you are well aware, provides the President of the Senate with the authority to "extend the time allowed for any committee," I ask for your consideration of this important request.

Thank you for your help with this very important matter.
