SB 90, Gooch, 51 st	_	Provide for the periodic submission of certain information by state, regional, and local
		transportation authorities to the Governor's Development Council

SB 130, Gooch, 51st – Provide for requirements for performing value engineering studies.

SR 740, James, 35 th	-	Dedicates the Private First Class Melvin Johnson Memorial Bridge.
SR 893, Hufstetler, 52 nd	-	Dedicates the corridor of State Route 53 from the Gordon County line to the city limits of Rome as the Shannon Industrial Parkway.
SR 937, Stone, 23 rd	-	Dedicates the portion of Ga. 67 in Jenkins County from the southernmost point of the Ogeechee River Bridges to its intersection with Ga.121 as the Albert Sidney "Sid" Newton Memorial Highway.
SR 975, Dugan, 30 th	-	Dedicates the portion of State Route 166 in Carroll County from State Route 100 to its intersection with Garrett Circle as the Col. L.E. Witt, Jr. Memorial Highway.
SR 1013, Carter, 1 st	_	Dedicates the portion of Interstate 95 in Liberty County from Exit 76 north to the Bryan County line as the Joe E. Brown Memorial Highway.
HB 264, Jacobs, 60 th	_	Reconstitutes the Board of Directors of MARTA; Allows nonparticipating counties to join MARTA; temporarily suspends the current restrictions on MARTA's use of sales and use tax proceeds.
HB 265, Jacobs, 80 th	_	Repeals three-year suspension of the restrictions on MARTA's use of tax proceeds, as well as the current membership of MARTA Board of Directors, if a bill is enacted this session that suspends the restrictions and reconstitutes the Board of Directors.
HB 775, Carson, 46 th	-	Removes a population provision in the definition of a "metropolitan area" as it relates to creation of a transit authority by special legislation of the General Assembly; requires intergovernmental agreements prior to operation of service by the transit authority when it is created in an area where transit service is already being provided.
