**HB 71 – LC 21 1886 – Riley, 50<sup>th</sup>** - Relating to certificated or uncertificated forms of investment and real estate investments, so as to increase the total percentage of investments permissible in real estate investments for the Georgia Municipal Employees Benefit System and any association of like political subdivisions which contracts with its members; to repeal conflicting laws; and for other purposes.....

**HB 232 – LC 21 1976 – Battles, 15<sup>th</sup>** – Relating to employee and other contributions in the Regents Retirement Plan, so as to change the level of employee participation; to repeal conflicting laws; and for other purposes....

**HB 238 – LC 21 2176S – Maxwell, 17<sup>th</sup>**- Relating to retirement benefits payable under the Public School Employees Retirement System, so as to clarify certain provisions relating to a limitation on the maximum level of retirement benefits; to provide an effective date; to repeal conflicting laws; and for other purposes.

**HB 345 – LC 21 2110 – Benton, 31<sup>st</sup>** – Relating to the Teachers Retirement System of Georgia, so as to clarify and consolidate the definitions of the term "teacher"; to repeal an obsolete provision; to repeal conflicting laws; and for other purposes ....
